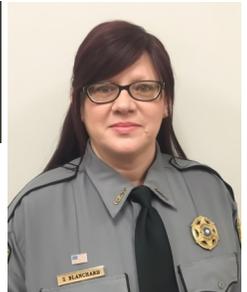

As so many of our communities are preparing for Mardi Gras balls, parades and revelries of all sorts, or planning for spring festivals, we wanted to take a moment and spotlight a community that practices great Communications Planning for Special Events, New Orleans OHSEP.

New Orleans OHSEP's Communications Lead is Adam Brickeen. Adam is responsible for coordinating all multiagency ICS 205 Communications Forms. Adam believes the value of a coordinated planning effort during special events is critical to achieving interoperable and operational communications for the event; however, "the greater long-term benefit is we build skills, exercise through implementation and continually build awareness during blue skies. Our incident communications planning and interoperability prove it."



LWIN was built and exists to support operational communications that are interoperable! Having a statewide system provides Louisiana LWIN agencies a head start on interoperability, if you've programmed properly. The SIEC established minimum programming standards for LWIN agencies, creating a backbone of interoperability for our First Responder community. Your EPTT may not meet policy standards. Know Before You Purchase!

Did you know there are several policies that govern LWIN use, access, and protocols on patching connections? Several vendor options are available today to enhance your communications capabilities. For instance, with the advent of FirstNet and Enhanced Push To Talk (EPTT) applications, agencies are looking into how best to take advantage of these. Please make sure to take into consideration that these are only recognized for "Non-Mission Critical" communications. If you are considering the purchase of any Radio Over Internet Protocol (ROIP) connections, take a moment to review SIEC Policy Number 006: Network Patching, and consult with LSP Radio Communications, prior to any purchase. 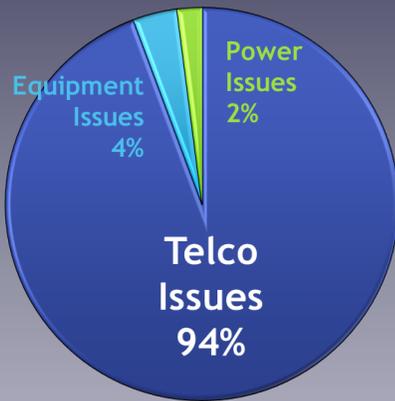

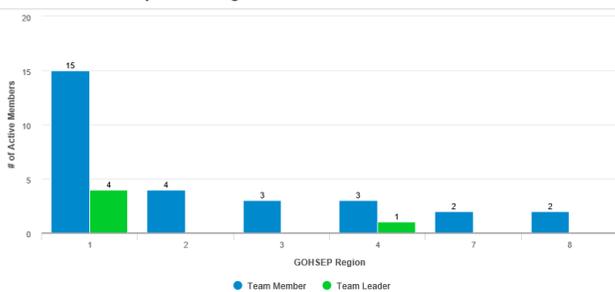
