STATEWIDE INTEROPERABILITY EXECUTIVE COMMITTEE MINUTES

Wednesday, June 27, 2007

The Statewide Interoperability Executive Committee (SIEC) met on Wednesday, June 27, 2007, at the Claiborne Building Conference Center, 1st Floor, 1-153 Iowa Room, Baton Rouge, Louisiana. Restated Actions from 6/13/07

On motion of Susan Severance, seconded by Eric Sivula, the Committee voted unanimously to approve the minutes of the May 23, 2007 meeting. Motion carries.

On motion made by Dick Gremillion, seconded by Eric Sivula, the Committee agreed to accept the report submitted by Chief Black and to defer discussion on the plan until more information is received on the plan's budgetary requirements and the interoperability needs of Regions 6, 7, and 8.

Approval of Minutes

On motion of Susan Severance, seconded by Eric Sivula, the Committee voted unanimously to approve the minutes of the June 13, 2007 meeting. Motion carries.

Assessment and Technology Committee

Brief comments were shared by representatives that attended the Region 4 meeting on June 19, 2007. Regional meetings will also be held in Regions 6, 7 and 8. Extensive discussion followed regarding the build-out of the 700 system. A possible location for the September SIEC meeting may be Alexandria, Louisiana. Committee member Sonya-Wiley Gremillion will check the possibilities and report back to the Committee.

Funding and Finance

In the absence of committee member Heyward Jeffers, there was no report from the Funding and Finance Committee.

Policies and Procedures

Susan Severance distributed a draft copy of the Cooperative Endeavor Agreement for review. The Committee discussed the Agreement in detail and made suggestions for revisions. Susan will finalize the Agreement and distribute to the appropriate entities.

Rizwan Ahmed discussed the creation of a Memorandum of Understanding identifying the roles and responsibilities of the city parish and statewide system. It was suggested that the MOU's for Louisiana State Police and St. James Parish could be used as a template. Susan Severance will draft a MOU and make available to the Committee.

Planning Committee

Dick Gremillion reported that the Planning Committee met with Region 8. They discussed developing a regional plan to submit with the grant application. It was suggested that the Region 1 plan could be modified to include specifics for Region 8. Detailed discussion of plan development and approval continued.

On motion of Eric Deroche, seconded by Dean Dozier, the Committee voted to allow Chairman Rizwan Ahmed to decide which state agencies will get radios at 15%. Without opposition, the motion carried.

Old Business

An inquiry was made regarding the status of the text-based messaging system. There has been no action reported or received in writing to date.

New Business

Christina Dayries informed the Committee that Col. Henry Whitehorn is retiring and a celebration will be held at the Hilton Capitol Complex on July 19, 2007 from 6:00pm to 10:00pm.

Adjournment

There being no further business, the meeting was adjourned at 4:15 p.m.
