III. Approval of Minutes

Chief Mike Knaps made a motion to approve the September 22, 2010 meeting minutes. Chief Ronald Bourque seconded. The SIEC voted unanimously to approve the minutes of the September 22, 2010 meeting.

IV. Chairman's Report

A. Opening remarks

Chairman Brant Mitchell began by giving an overview of the LWIN capacity expansion project. Equipment is being delivered and DPS is working on an installation schedule.

Chairman Mitchell reported that the Office of Interoperability will be using FY08 IECGP grant funds to print a LA State Tactical Interoperable Communications Field Operators Guide (TICFOG). Chairman Mitchell asked that parish representatives send in their local frequency information for inclusion in the TICFOG.

Chairman Mitchell gave a report on the current status of the establishment of RICs and PICs in the State.

Chairman Mitchell gave a summary of the VHF/UHF narrowbanding deadline. A narrowbanding working group will be established to come up with a plan to provide assistance to those who are in the process of narrowbanding.

Chairman Mitchell presented the NECP Goal 2 evaluation process and the tools that will be used to report on Goal 2.

Chairman Mitchell reported that the Tait radios have been approved for use on LWIN.

Lastly, Chairman Mitchell reported that LWIN has surpassed MPSCS (Michigan) and CCNC (Colorado) as the largest statewide radio system in the country.

VI. Sub-Committee Reports

A. Technical Sub-Committee

Technical Sub-Committee Chairman Eric Deroche stated that the Technical Sub-Committee has been working with GOHSEP and DPS to identify sites for the capacity expansion project.

B. Policy and Planning Sub-Committee

Policy and Planning Sub-Committee Chairman Bill presented the recommend policy changes to be adopted by the SIEC. The following was discussed and agreed upon:

- Policy 09-003 will be adopted (Motion by Chief Merrick Tassin to adopt, seconded by Eric Deroche, and approved unanimously)
- 700 MHz Mutual Aid Channels Recommendation this will be published as a "Best Practices" recommendation on programming the nationwide 30 700 MHz Mutual Aid Channels into radios.
- C. Budget and Finance Sub-Committee

Chairman Mitchell reported that the Office of Interoperability has received the budget recommendation from the State, and that it is the same as the last fiscal year.
