STATEWIDE INTEROPERABILITY EXECUTIVE COMMITTEE MINUTES Wednesday, May 2, 2007

The Statewide Interoperability Executive Committee (SIEC) met on Wednesday, May 2, 2007, at the East Baton Rouge Parish Emergency Operations Center, Baton Rouge, Louisiana. In the absence of Committee Chair Rizwan Ahmed, Heyward Jeffers acting as Vice Chairman, called the meeting to order at approximately 10:20 a.m. The roll was called by Ms. Lorita Ford; however there were not enough members present to establish a quorum. No official actions could be taken, and the meeting was held as an informal discussion.

Since a quorum was not present, the minutes of the April 25th meeting were not approved. They will be approved at the next full meeting of the SIEC.

The members discussed ideas and suggestions as possible responses to SB 274. A handout was distributed from Louisiana State Police and Heyward Jeffers regarding their comments and/or suggestions for SB 274. An attempt was made to peruse the bill line by line, however it was agreed upon that everyone could make their comments via listsery. Col. Whitehorn suggested that a member of the SIEC LANG support staff be responsible for facilitating the committee's re-draft of Senate Bill 274 and integrate the members' comments into one document for the committee's review.

There was brief discussion on whether vendors should be included on the listsery. Since the listsery is to be used exclusively as a discussion tool between the committee members, the consensus of the group was that the inclusion of vendors on the listsery would be a "conflict of interest." The SIEC meetings are open to the public and the approved minutes are posted to the SIEC website. If necessary, this could be an agenda item for the next meeting.

There being no further business to discuss the Statewide Interoperable Executive Committee meeting was adjourned at approximately 11:50 a.m.
