A. Opening remarks

Chairman Brant Mitchell began by giving informing the SIEC of a letter that the governor has sent to Senators Rockefeller and Hutchinson endorsing their bill to allocate the D Block to Public Safety.

Chairman Mitchell reported that the Narrowbanding working group has been established. This working group will provide assistance to first responder agencies that are relying on VHF and UHF systems.

Chairman Mitchell reported that Travis Johnson will be participating in the Texas Emergency Management Conference and participating in panel discussions.

Chairman Mitchell gave a summary of the status of the Baton Rouge simulcast project and a new site to be located in south Baton Rouge. The Simulcast will sites will be the Lobdell, LSU, and West Baton Rouge sites.

Chairman Mitchell reported that he and Ken Hughes have been selected to serve on the FCC Public Safety Advisory Committee.

Chairman Mitchell reported that the Tait radios have been approved for use on LWIN.

Lastly, Chairman Mitchell reported BP has approached the state with the possibility of donating VHF and UHF radio equipment to the state. If the

donation occurs, the SIEC Technical Subcommittee will be charged with formulating a plan for the distribution of the equipment.
